Two Bathroom and two Toilets are available here for the children and staff.

The LAPA/SAA and Children home for 0 to 6 years for 10 Children has 1 Living Room - (10 x 9 sq. ft.), for superintendent, 1 Room (10 x 15 sq. ft.), for Office Room, 2 Rooms for living (25 x 18 sq. ft.), One store Room (15 x 10 sq. ft.), for kitchen , one Room (20 x 23 sq. ft.) for Dinning Room , Two (05 x 04 sq. ft.) for bathroom , Two (5 x 4 sq. ft.) toilets, Water connection and Electric Connection with the accommodation is very safety.

15. MANAGING COMMITTEE

The Managing Committee elected by the members of A.G.M held on 30/05/2011 which is approved by the District Magistrate Malda.

16. MONITORING COMMITTEE

In terms of order of the Director of Social Welfare, vide No. 6765, dated 1995, the Monitoring Committee constitute with 14 (fourteen) members.

17. SANCTION STRENGTH OF THE INMATES

The sanction strength of the Home is 10 (ten) of an age group of 0 - 6 years.

18. STAFF

As per I.C.P.S scheme we appointed one Superintendent, One Social Worker, One Nurse cum Warden, One Medical Officer, One Chowkidar and Six Ayas.

19. BANK ACCOUNT

The Financial transaction is made from S.B.I, Malda Branch vide Account No. 30843939209. The joint signatories are the Secretary and The Treasurer of the organization.

20. GRANTS

From the establishment of the Home neither from the State Government nor from the Central Government any grant is received.

21. AUDIT

The audit up to 31st March 2011. The name and address of the auditor is S.K.Kundu & Associates, Rahini Sadan, Rathbari, P.O. & Dist. Malda. Name of the Chartered Accountant is Sri Subhra Kundu.

22. REGISTER

As per CARA (Central Adoption Resource Authority under Ministry of Child Development, Govt. of India) guideline the organization maintains Leave Register, Money Receipt Register, Cash Book Register, Ledger Book Register, Stock Register, Attendance Register, PAP Register, Court Register, Admission Register, Medical Register for special needy children, Childs Medical Report (MER), Child study Report (CSR), Data on Adoption Register, Home study Report of Prospective Adoptive Parents Register, Letter Issue and receive Registers properly.

23. MEDICAL CARD

As per prescribed format (regarding Health of C.W.C, Malda) and CARA are maintained properly.

24. FOOD CHART

As per prescribed format regarding food C.W.C Malda are maintained properly and it is also displayed in front of the Visitor's Waiting Room, Office Room and inside building of the Home.

25. AMBULANCE FACILITY

The organization provides day & night Ambulance facility for service.

26. SECURITY ARRANGEMENT

Five trained Ayas for looking after Children and one Night Guard for security purpose have been provided. More ever Inverters, Fire Extinguisher, First Aid box, Tube Well, Purified Arsenic Free Drinking Water facility are also available.

27. OTHER HEALTH FACILITIES

The B.P.H.C Chandipur stands within 100 meters and Malda Medical College Hospital in within 7 km.

28. OTHER CHILD WELFARE ACTIVITIES RUN BY THE HAIDERPUR SHELTER OF MALDA

- a) According to recognition Department of Mass Education Extension Govt. of West Bengal the Residential & Treatment biased Education Programme for Mentally Retarded Children is going on.
- b) According to approval of District Magistrate, Malda the Child Helpline (24x7) for Child marriage prevention programme is going on.
- c) According to sanction of Department of Women and Child Development and Social Welfare, Govt. of West Bengal the Cottage (6 to 18 years Children) is going on.
- d) According to registration under West Bengal Women's and Children Institution (Licensing) Rules, 1958, the C.N.C.P Home will be started very soon.
- e) According to permission of Malda District Child Protection Society (DCPS) to act as a service provider for food supplier to J.C.L children at J.J.Board.
- f) According to permission CMOH, Malda the Child Immunization center (as per Govt. Schedule) is going on at Piyaji More.
- g) According to permission D.M Malda anemia control programme is going on for School children.
- h) According to Recognition of D.M, Malda the awareness programme regarding the Anti Child Marriage programme is going on.
